Bylaw 15. New Zealand International Salon

INTRODUCTION

Under the Constitution of the Photographic Society of New Zealand Inc. (PSNZ) the Executive Officers have been given the power to create and set Bylaws that are applicable to the description of specific events, activities, jobs, portfolios and/or publications that fall within the operations of the Society.

Objectives of this Bylaw

This Bylaw is intended to outline the processes and jurisdiction given to the organising committee for the conduct of the New Zealand International Salon so that they may organise a successful salon that meets the needs and educational objectives of the Society – "Helping Photographers Grow".

1. Purpose

The purpose of the Salon is to:

- promote photography in all its aspects in both prints and projected images.
- promote a wider understanding in the art of photography on an international basis.

2. Entries

The Salon is open to all photographers worldwide.

3. Venue

The New Zealand International Exhibition shall be held in conjunction with the National Exhibition and given a space of its own within the main Exhibition.

4. Categories

The club organising the National Exhibition shall organise the space for the New Zealand International Exhibition in accordance with directions given to it by the New Zealand International Salon committee and FIAP/PSA rules and guidelines regarding Exhibitions.

5. Accounting and Finance

The accounting and finance requirements for International Salons shall be in accordance with the budget approved by Council.

6. Judging

- (a) The Committee, after consultation with, and the approval of, the Councillor for International Salons, will appoint Panels of Selectors from a list of suggested Judges.
 - This list will be obtained from the Judge Accreditation Panel by the Councillor for International Salons.
 - A selection panel consists of 3 (three) persons.
 - At least one member of each panel must be the holder of a FIAP distinction.
- (b) The selectors are to be advised of the rules and requirements of both FIAP and PSA when judging an international salon.
- (c) All entrants are to receive notification of the results of the selection by report card, which shall be emailed within seven (7) days of the selection.

7. Catalogue

A catalogue is to be compiled as a PDF which must include the names of all exhibitors together with the title of their projected images or prints in accordance with the rules and guidelines of FIAP and PSA. A statistical table must be included showing the countries of origin, the number of entries from each and the number of selected entries from each. The catalogue will include reproductions of projected images and prints.

All salon results and other files required to be sent to FIAP and PSA must be sent in accordance with the respective guidelines as set out in the following manuals:

- FIAP: Conditions and regulations for FIAP patronage.
- PSA: Exhibition Standards.

These manuals will be updated each year by the FIAP Liaison Officer and sent to the Councillor for International Salons. They will be made available to the Salon Chairman.
