Registration Number: CC29972

### **Purpose or Mission**

The purposes of the Society are focused on the advancement of photography as a craft and art form while promoting friendship, education and development through the exchange of information and ideas on photography among the members.

### **Entity Structure**

A membership-based Society with a Council of two elected officers, plus one ex-officio officer and eight Councillors. The Secretary and Treasurer are appointed by the Council.

## Main Methods Used by the Entity to Raise Funds, and main sources of cash and reserves:

Members including affiliated Clubs and Societies pay an annual subscription. Additionally, the Society earns interest from invested funds. During the year the Society holds conventions for the benefit of members (one or two regional and one national). Members pay to attend these. Sponsorship is sought for these events. Depending on the success of these events, half the surplus is shared with the hosting club, with the other half retained by the Society.

### **Entity's Reliance on Volunteers and Donated Goods or Services:**

The Society is uniquely driven by volunteers and professional leadership. The Society convenes local member Clubs and Societies to organise and run events on behalf of the Society.

### **Additional information:**

The Society is affiliated to the following associations:

- Federation International de L'Art Photographique (FIAP), an umbrella organisation for recreational photographers around the world.
- The Photographic Society of America (PSA).

These consolidated financial statements include the financial activities of the Bowron Foundation (a trust settled pm 25 January 1969 by Frederick Bowron with objectives the same as that of the Society). Financial statements of the Bowron Foundation are required by law to be consolidated with PSNZ for reporting purposes, on the basis that PSNZ has control over the operation of the Foundation as the Council of the Society acts as Trustee of the Foundation.

## **Photographic Society of New Zealand Incorporated Presidents report**


For the year ended 31 December 2022

It gives me great pleasure to present my second president's report. It would be fair to say that it was a year that was dominated by Covid and therefore forced us to adapt even more than the previous two.

### Membership

After a year of relative stability we saw a drop in membership numbers by 56 which included 14 members who sadly passed away throughout the year. The drop is understandable given the way that many of our major activities throughout the year were curtailed, and this has had an impact on new members joining. The graph below shows the trend in membership over the last nine years.

### Council

As was noted in the previous Performance Report, 2021 saw the single largest change in the structure of the PSNZ Council. With a significant number of new members joining in September, the first quarter of 2022 was spent with the council still coming to grips with their portfolios. With the exception of Sue Wilkins LPSNZ and Craig McKenzie, all Council members sought re-election at the 2022 AGM In April.

Craig has served on Council for a number of years looking after Salons and had a wealth of knowledge, especially when it came to nature which was his specialty. I thank Craig for all of the work that he had put in.

Sue had a change in work circumstances that limited her involvement. While she stepped down from Council, she has continued to help run the closed Facebook group. The role of Councillor for Communications is one that the Society had struggled for a number of years to fill and this has continued throughout the year. I thank Sue for her work on Council.

At that AGM we also said farewell to IPP Moira Blincoe LPSNZ who had served the Council for some 11 years. She has continued to be a valuable resource to both me and the Council and I thank her for all she has done.

In September Councillor for Liaisons Jane Muller stepped down and she was replaced by Sandy Odell. Thanks to Jane for her work while on Council. At the same time Caroline Ludford LPSNZ LRPS came onto Council to take up the Salons role. Also coming onto Council at the same time was Lee Boddington. Lee answered the call for someone willing to come onto Council with the specific intention of moving into the President's role in 2024.

### Conventions

Coming into 2022 we had hoped that we would be able to run a full complement of conventions but that was not to be. The traffic light system that operated at the start of the year made it very difficult to hold larger events, and also many members were not keen on such gatherings. When it was clear that we would not be in a "Green" setting by April, Council made the hard decision to cancel the National Convention in Rotorua. For the team trying to put the National together, this was the second convention that had been affected by Covid, so a further decision was made to postpone having any regional conventions until 2023 when we hoped they could be held without interruption.

The one positive that came out of the planning for Rotorua was the realisation of how difficult it was to organise a traditional convention when the organisers were not based in the area. This led to us looking at the whole structure of the events as well as the timing.

With the decision to decouple the AGM from the Convention, there was no need to hold it in April and so the decision was made to move the Convention to October, as that fitted much better with the timings of both it and all of the other events that lead into it.

### **Publications**

*New Zealand Camera* continues to be our flagship publication, although its distribution in 2022 was anything but smooth. We had another year of a large number of entries.

The 2022 panel was made up of Annette Johnston FPSNZ, Toya Heatley APSNZ AFIAP, and Daniel Wong APSNZ who returned for their third and final year. They were joined by Helen Wilkins FPSNZ MNZIPP who replaced Susie Whelan APSNZ MNZIPP (Dist I). Councillor for Publications, Richard Laing, undertook the administration work needed to ensure all members were advised of their results. I thank all these members for their service during the year, especially as being a selector means that they could not submit their own images for consideration.

The global supply chain issues caused by Covid had a major impact on delivery of the 2022 NZ Camera, with books taking five weeks longer to arrive than previous years. This meant that the majority of books could not be delivered via the usual method of sending them to clubs. Rather all books had to be sent directly to members which resulted in the distribution costs being considerably higher than in previous years.

CameraTalk continued to be published throughout the year, to a very high standard equal to any published magazine on the market. After the June 2022 issue was produced, editor Mark Chamberlain LPSNZ moved back to Australia. Richard Laing picked up the editorial function, working with Lindsay Stockbridge LPSNZ (sub-editor) and Ana Steven APSNZ (Designer).

### **Honours Board**

The Honours Board meeting was another event affected by Covid and its normal meeting in March was pushed back to late June. The hard work that Bruce Girdwood FPSNZ put into both the previous year's feedback and online sessions has started to show results.

Overall, the number of applications increased by 24%, and the overall success rate for applicants improved in 2022 to 60% from 49% the previous year. The full breakdown of results can be found on page 13.

I thank Bruce, Secretary Stephanie Forrester APSNZ and Board members: Ann Bastion Hon PSNZ FPSNZ EFIAP MFIAP, Paul Byrne FPSNZ ARPS AFIAP, Helen McLeod FPSNZ GPSA ARPS, Gail Stent FPSNZ and Ian Walls FPSNZ for their efforts this year.

As President I was able to witness the assessments of the Fellowship sets in person and can truly say that the Board works in a very constructive and positive way in assessing them.

### **Judge Accreditation Panel (JAP)**

Four training weekends were planned for 2022, however because of COVID only one was held in person. After the cancellation of the second event, it was decided to take the last two sessions online using Zoom. This proved to be a success and so in 2023 the majority of sessions will be carried out in this way.

The breakdown of the Judge training sessions is on page 13. The training weekends are heavily subsidised by PSNZ.

After many years of service Newell Grenfell Hon PSNZ FPSNZ FNPSNZ stepped down from the panel and was replaced by Aliah Jan FPSNZ. I thank Newell for all that he has done for the Society. With her move onto Council, Panel Chair Caroline Ludford LPSNZ LRPS stood down from JAP and was replaced by Paul Byrne FPSNZ. Thanks to Caroline for all her hard work as Panel Chair.

At the end of the year Shona Jaray also stepped down from her 11 years of involvement in the training process. I sincerely thank Shona for this outstanding effort.

During the year four people were accepted into the accreditation process and four judges completed their training and were accredited in the Open category.

### Salons and competitions

PSNZ continued to operate the majority of the usual salons and competitions in 2022. The exception was that entries in all salons were limited to digital. The decision was made because we knew that the events could be run remotely through all stages and would not be impacted by Covid.

### **PSNZ Sony National Exhibition**

The PSNZ Sony National Exhibition was organised by a team from Dunedin Photographic Society with the results displayed using the PSNZ YouTube channel. The presentation of the awards was made at the special zoom session. As shown on page 14, the overall entries for the exhibition were slightly down on 2021 when looking only at digital entries.

As with previous years a digital catalogue was prepared and along with the AV of the digital sections shared with the wider membership. We thank Sony New Zealand for their continued support of the exhibition.

### Interclubs

The two digital interclubs were run alongside the PSNZ Sony National Exhibition and utilised the same selectors. Entries were on a par with 2021 for the individual competitions and the breakdown is shown on page 14.

We are hopeful that with the move of the interclubs away from the busy Christmas period that we will be able to increase competition numbers in 2023.

#### Canon Online

The six rounds of the Canon Online competition continued through 2022 without any disruptions. Paul Willyams APSNZ AFIAP MNZIPP stepped down from the role of convenor at the end of the second round and was replaced by John Hawkins. I thank Paul for the work he did with the competition.

It was a little disappointing to see entries fall in 2022.

We thank Canon New Zealand for their ongoing support of this event.

### Jack Sprosen Memorial Trophy (JSTM)

The JSMT is a digital competition for audio-visual presentation containing the photographic work of the creator. The competition is normally held in October with the presentations occurring at the national convention. With the move of the convention from April to October it was decided not to hold the competition in 2022.

### **4 Nations**

This is an annual competition with the photographic organisation in Australia, Canada, South Africa and New Zealand. In 2022 the event was hosted by South Africa. I would like to thank Toya Heatley FPSNZ, Craig McKenzie and Alison Viskovic FPSNZ who assisted me with the selection panel and Bob Scott LPSNZ who coordinated the New Zealand entry.

New Zealand came third in the competition. Congratulations go to Karen Moffat-McLeod APSNZ who was the only PSNZ member to receive an award with an Honourable Mention in the "Monochrome" section.

### **Workshop Series**

2022 saw the fourth year of the very successful programme of workshops run around the country, with an ambitious programme of ten events planned. As in previous years, registrations were split into groups and members were only able to register for one workshop during the year, however they could attend more if there were spaces available close to the time that the workshop started. We were fortunate in that we managed to run nine without Covid disruption and the one that was cancelled was done so because of low registration numbers.

Feedback received from participants continues to be extremely favourable.

I want to thank the Workshop Series committee of Karen Moffatt-McLeod APSNZ, Nicole Tai and Jayne Parker for the work they put into smooth operations of the workshops. Also thanks to our workshop presenters: Toya Heatley FPSNZ, Karolina Ferbei, Meghan Maloney, Joseph Pooley, Greg Stevens FPSNZ, Judy Stokes APSNZ and Helen Westerbeke FPSNZ. In addition thanks to Graham Dainty FPSNZ who was scheduled to run the one workshop that could not go ahead.

We also must acknowledge the support of Sony in the running of Meghan Maloney's session.

### International

Despite closed borders members are still active in the international circuits and are achieving their FIAP distinctions. I want to thank Ann Bastion Hon PSNZ FPSNZ EFIAP MFIAP who continues to guide members in her capacity of FIAP International Liaison Officer.

PSNZ also entered a set of images into the 35<sup>th</sup> FIAP Black & White Biennial held in Oman. The images had been collected for the 2020 competition that did not occur. Ian Walls FPSNZ and Mike White APSNZ whittled the entries down to the 10 selected.

New Zealand came 6th for cohesiveness with 37 points out of possible 60 and finished 13<sup>th</sup> out of 46 countries.

### **Trade Partners**

The Society continues to enjoy strong and healthy partnerships with the key brands within New Zealand's photographic industry, namely: Sony New Zealand (for the Sony National Exhibition); Canon New Zealand Ltd. (for Canon Online); CR Kennedy Ltd (for the PSNZ Honours Banquet); Nikon; Epson; Panasonic NZ Ltd; Fujifilm NZ Ltd. and Ilford.

The year represented a watershed in the way that the contracts were structured, as in the past they had been totally linked to their attendance at the National Convention. Without the convention this represented a significant decrease in the financial support to the Society. I commend Councillor for Partnerships Aston Moss for the outstanding work he has carried out to secure better arrangements. Our members appreciate the opportunity to be able to engage with them.

### **Finale**

As I write this, I am coming up to end of my second year as President and I can honestly say that the last 12 months have been quite difficult especially as we had to curtail so many activities in order to be able to carry on. This can be very demotivating to people.

I want to thank all those who step up and contribute their time for the organisation. I am especially grateful to my Vice President, Toya Heatley, for all the support she has given me in the role.

# Photographic Society of New Zealand Incorporated Treasurers Report For the year ended 31 December 2022

It gives me pleasure to present the consolidated accounts of PSNZ and the Bowron Foundation for the year ending December 31, 2022.

Overall the year ended with a surplus of just over \$40,500. However, this includes a refund of the deposit of some \$9600 for the hiring of the National Convention venue in 2021, which did not take place due to Covid restrictions. There were no National or Regional Conventions during 2022, which has led to a reduction in gross income for the period. Surplus cash funds during the year were transferred to term deposits.

As the Society has again returned a surplus of income over expenditure, I am recommending that subscriptions remain at the same level in 2023. I am also recommending that consideration be given to using surplus funds to further subsidise workshop activities.

## Photographic Society of New Zealand Incorporated Statement of Accounting Policies

### For the year ended 31 December 2022

### **Basis of Preparation**

The Photographic Society of New Zealand Incorporated has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses of equal to or less than \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

### Goods and Services Tax (GST)

All amounts are recorded exclusive of GST, except for Accounts Receivable and Accounts Payable which are GST inclusive. The Statement of Cash Flows for 2021 was inclusive of GST.

#### **Income Tax**

The Photographic Society of New Zealand Incorporated is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

### **Income Recognition**

Revenue from Fees, Donations and Grants received is recognised in the Statement of Financial Performance as the services are provided. Subscriptions and other revenue are recognised at the point they are receipted into the society's bank account. Interest received is recognised on an accrual basis.

### **Bank accounts and Cash**

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

### **Accounts Receivable**

Accounts Receivable represents items that the Society has issued invoices for or accrued for but has not yet received payments for at year end. Receivables are initially recorded at fair value and subsequently recorded at the amount the Society realistically expects to receive. A receivable is considered uncollectable where there is objective evidence the Society will not be able to collect all amounts due. The amount that is uncollectable (the provision for un-collectability) is the difference between the amount due and the present value of the amounts expected to be collected.

#### **Accounts Payable**

Accounts payable represents liabilities for goods and services provided to the Society prior to the end of the financial year which are unpaid. Accounts payable are recorded at the amount of cash required to settle those liabilities. The amounts are unsecured and are usually paid within 30 days of recognition.

### **Revenue Received in Advance**

Revenue received in advance relates to fees and from grants where there are unfulfilled obligations on the Society to provide services in the future. The fees are recorded as revenue once the obligations have been satisfied.

### **Property Plant & Equipment**

Depreciation has been charged in the financial accounts using the following rates using the diminishing value method:

COVID-19 continued to disrupt the activities of the Society in 2022 with the cancellation of the North Island Regional Convention in Rotorua and the National Convention in Lower Hutt, one workshop and two judge training weekends. Furthermore two workshops held in October went ahead with lower numbers than originally planned, but were held via Zoom meetings, rather than face-to-face. The cancellations of the National Convention and the Regional Convention were unfortunate but given that there would have been expenses involved with those events, the impact on the Society was not as great as might have been thought. The refund of the National Convention accommodation hire took place after the accounts were finalised for 2021 and have been shown as a credit to the expense for 2022.

### 21: Events after the Balance Date
